A sammelband of eight early nineteenth-century pamphlets relating to the governments of Scotland, England, and the United States.

The first mentioned work, by an anonymous 'Freeholder of the County of Ross', vehemently criticises the introduction of an 1808 Act which temporarily prohibited the distillation of sugar from corn, arguing the government's claims for introducing the measure, notably alleged scarcity of grain and the need to support West Indian merchants, are wholly unfounded.

The second mentioned pamphlet surveys the political tensions between the Federalists and Democrats, and between France, England and the United States, which culminated in the War of 1812. *The Edinburgh Monthly Magazine* (Vol. I, 1817, p.414-415) attributes the work to Samuel McCormack.

Though often containing a modicum of useful wisdom, some of the selections are designed merely to entertain, for example under the heading 'Very Funny', one finds the following quip: 'Father do they light up railway carriages at night with gas?' 'No, my dear, with train oil.' Presumably one had to be there.

This edition, one of several appearing at Glasgow and Alnwick in the midnineteenth century, appears unrecorded by OCLC or COPAC.





The first edition of a collection of papers relative to the Bannatyne Club and its publications. This, partially interleaved, copy includes the addition of two contemporary presentation inscriptions: 'For the Right Honourable / Sir James Mackintosh / from his affectionate friend / Tho. Thomson / Charlotte Square / Edin. Jan 28. 1830', and 'To T. G. Wright Esq. / With my affectionate regards / J. Nairne / 24th Sept. 1830'.

The first is in the hand of record scholar and advocate **Thomas Thomson (1768-1852)**, a prolific editor for, and sometime vice-president of the Bannatyne Club, with whom he issued fourteen historical texts, including *The History and Life of James the Sext* (1825).







A Victorian manuscript copy, in at least two unidentified hands, of the general military order for several British Regiments during the campaign in Scotland 1745-46, including (according to a later manuscript note to verso of FFEP) those of Lieutenant Archibald Campbell of the 3rd Regiment of Dragoons who was aide-de-camp to General Bland and served under 'Butcher' Cumberland at the Battle of Culloden.

Campbell's military order books have seemingly never been published; the originals are preserved at the National Army Museum (NAM 1968-07-228).





The first edition – in original state - of a succinct history of, and guide to, Inverness.

The latter half of the text, devoted to the primary structures of the Highland city, includes a brief notice on local libraries: 'The principal Circulating Library is kept by Mr Douglas, and consists of upwards of 6000 volumes', and a passage on municipal printers: 'Inverness possesses several excellent printing offices. The principal are the newspaper offices; but there are others which, although they do not command such a variety of types, are, notwithstanding, good jobbing offices. Much inconvenience has occasionally been felt for the want of a copperplate and lithographic press in the town. Work of this description has to be sent to Glasgow, Edinburgh, or Aberdeen'.

The sole edition of a monograph on the benefits of establishing parish schools in urban areas by Church of Scotland minister and social reformer Thomas Chalmers (1780-1847).

The inclusion of 'Large Towns' in this title presages his later work *The Christian and Civic Economy of Large Towns* (1821-6, Glasgow). A dedicated and tireless social reformer, Chalmers, following the Disruption of 1843 and the Free Church of Scotland, erected over 500 parochial schools in the country.



The first edition of a succinct survey, by publisher Robert Chambers (1802-1872), of notable conflagrations throughout the history of Scotland's capital, including a detailed account of the Great Fire of Edinburgh that began on 15th November 1824 and raged for five days, decimating the area surrounding Parliament Square. The fire began at the premises of engraver James Kirkwood and ultimately engulfed 400 homes, killing at least 10 people.





The manuscript diary of Betty Angus of 5 Chester Street, Edinburgh, commencing on Saturday 16th July, 1904, and concluding on Saturday 31st December. A devoted church goer, and apparently devoutly pious woman, Betty's life is quiet and rather idyllic, her time devoted primarily to reading (with purchases made at Douglas and Foulis) and playing bridge.

A notable exception to her unassuming routine is a cycling trip taken to Inverness in August, during which she ventures to Culloden Moor to visit the Cumberland Stone and the graves of the clans who fought at the Battle of Culloden, which with characteristic quietude our diarist simply records as 'very interesting indeed'.

Sir Alexander Russell Simpson (1835-1916), Professor of Midwifery. Sir Alexander's famous contribution to the field are the obstetrics forceps, which reduce pain for the mother during childbirth and aid delivery.

**Sir William Turner (1832-1916),** Professor of Anatomy who spent the twilight of his career as the Principal of the University of Edinburgh. He was the author of the influential Atlas of Human Anatomy and Physiology (1857).

**Sir Robert Christison (1797-1882)**, physician specialising in toxicology, and the first person to describe renal anaemia. In 1848, he was appointed physician to Queen Victoria, who awarded him a baronetcy in 1871 for his dedication.

Thomas Annandale (1838-1907), surgeon who served as Regius Professor of Clinical Surgery at the University. Among his professional achievements, Annandale developed a novel approach for inguinal hernia repair, performed the first repair of the meniscus, and conducted the first extraction of an acoustic neuroma.



An undated, although apparently eighteenth-century transcription, in a single legible hand, of the journal of John Erskine of Carnock (1662-1743) for the period between 5th June, 1683 and 26th May, 1685. Not published until the Scottish History Society edition of 1893, the journal gives a detailed account of the period between the Restoration and the Revolution. As an aspirant to the Bar, Erskine attended the courts where those apprehended in the aftermath of the Battle of Bothwell Bridge were tried and sentenced to death or banishment. Typical of such entries is this from 1684: '25th Jul last. Mr. Will Spens sometimes Argyles Secretary was put in the boots & received many strokes till his leg was crushed...having yet discovered nothing he was taken...to the Canongate...& set upon a form where he had nothing to lean on, the soldiers being commanded to keep him from sleep which they did till Saturday the 2nd August'. In addition, numerous references are made to the transportation of prisoners to North America, specifically Carolina.

Erskine's Presbyterian sympathies led him to join with the army of William of Orange, where he was given command of a Regiment of Foot, participating in the invasion that commenced the Glorious Revolution of 1688. In return for his service, he was given further commands in William's army and, in 1695, he was appointed a director of the newly founded Company of Scotland Trading to Africa and the Indies. He was the father of noted advocate and jurist **John Erskine (1695-1768)**, author of *Principles of the law of Scotland* (1745).

#### The causes of Men wanting Money.

Since money is a thing so necessary and so useful, and the want of a competency of it, makes a man so very miserable, rendering him liable to all the scorn and contempt that an ill-natured world can throw upon him; it seems strange so many should want it, especially those that know the worth of it. And therefore it may be worth our enquiring into the causes from whence this want proceeds: I mean the common and ordinary causes; for there are some causes that are extraordinary, such as all our wit and prudence can neither foresee nor avoid. Such was that extraordinary and surprising storm in November 1703, whereby many thousands were undone, as to their estates, besides the many lives that were lost; and such also was the dreadful fire in Lon17

don, whereby some that had great estates the one week, had scarce bread to eat the next: and in the time of war many are unavoidably losers. But these must not be reckoned the common and ordinary ways that make and keep men poor. We know indeed, that by the divine providence, in the body of a common-wealth there must be both poor and rich, even as an human body cannot subsist without hands and feet to labour, and walk about to provide for the other members; so the rich being the belly, which devour all, yet do no part of the work; but the cause of every man's poverty is not one and the same; some are poor by condition and content with their calling, and neither seek nor can work themselves into better condition; yet God raised up, as by a miracle, the children and posterity of these, oftentimes, to possess the most eminent places either in church or common-wealth, as to become Archbishops, Bishops, Judges, Commanders-general in the field, Secretaries of State, Statesmen, and the like; so that it proveth not always true which the poet says,

If poor thou art, then poor thou shalt remain; Rich men alone do now rich gifts obtain

Of this condition are the greatest number in every kingdom; others there are, who have possessed great estates, but these estates have not thriven



The first is a supernatural tale, with decidedly Gothic overtones, in which, the night following the death of his uncle, a young man is disgusted to find his relatives mocking the character of the deceased. The rowdy party is duly visited by an apparition who chastises them for their behaviour, driving them from the premises. The young man is then shocked when confronted by the figure of his uncle, seemingly returned from the grave. He is soon disabused of his spectral supposition upon discovering that his uncle had been alive and well the entire time, the ghostly goings on merely a ruse to ascertain which of members of his family deserved to inherit his property.

The second story, set on an islet in the midst of Strangford Lough, Ireland, concerns the failed attempt of taxman to collect a considerable sum from the sole resident, a wily old dealer in rabbit skins.

The final tale, 'Scarlet Discovered', is an amusing comedy of manners in which a Highlander outwits a Perth haberdasher who jeeringly mocks his intelligence, a broken bloodily nose his reward.





A mid-eighteenth-century chapbook edition of the life, and ultimate execution, of thief and murderer David Haggart (1801-1821). On the bankruptcy of the firm of millwright for which he worked, Haggart turned to petty theft, becoming a regular pickpocket at fairs and racecourses around Kendal, Carlisle, and Newcastle, and sometimes as far north as Aberdeen. He was apprehended and imprisoned on six occasions, in four instances managing to escape from gaol. On 10th of October 1820, in escaping from Dumfries tolbooth, Haggart felled one of the guards with a stone, killing him. He remained on the run for several months before being re-arrested in March 1821. He was tried on the 11th of June found guilty of murder. A few days later he was hanged. While in gaol he partly wrote and partly dictated an account of his life and crimes, entitled Life of David Haggart, which was to be published after his death by George Robertson. The present chapbook appears to be a heavily reworked abridgement of the book, omitting the Scottish thieves' cant of the original.

The first edition of writer and literary editor John Gibson Lockhart's (1794-1854) remarkably popular triple-decker epistolary fiction satirising prominent Scotsmen of the age, issued under the pseudonym of itinerant Welshman Peter Morris M.D. Despite the title page statement, this is the first edition and not the second - a deliberate obfuscation, designed to compliment the satirical nature of the work and obscure the author's identity. This act of misdirection was further galvanised by Lockhart's anonymous review of the fabricated 'first edition' in Blackwood's Magazine prior to publication.

The subscription library at Colinsburgh, Fife, survived until at least 1860 (Slater's Royal National Commercial Directory and Topography of Scotland).





The majority of its archaeological and historical conclusions are, by contemporary standards spurious, too reliant on the Ossianica of James Macpherson. The work does however contains much of value regarding traditional highland lore and the Gaelic language.



Sir George Mackenzie of Rosehaugh (1636/38-1691), Scottish lawyer and essayist, his Laws and Customs of Scotland in Matters Criminal was the first systematic and detailed exposition of Scots criminal law. To begin what would be a prestigious and influential career, Mackenzie assisted in the Midlothian Trials for witchcraft in 1661, providing defence for one of the alleged. Later, during his tenure as Lord Advocate, Mackenzie became the minister responsible for the persecuting policy of Charles II against the Presbyterian Covenanters, thereby being held accountable for the deaths of hundreds due to maltreatment following the Battle of Bothwell Bridge - thus earning him the monicker of 'Bluidy Mackenzie'.

The tenth article is devoted entirely to the identification and punishment of practitioners of witchcraft, including determining 'whether a witch can cause any person be possest', whether transformation be possible', 'whether they can procure love by their potions', and 'whether Witches may kill by their looks'.





The second pamphlet, commonly attributed to journalist and pamphleteer George Ridpath (d. 1726), provides a succinct account of the Massacre of Glencoe - the slaughter in 1692 of members of the MacDonald clan of Glencoe for failing to promptly abandoned their allegiance to James II and pledge oaths of fealty to William III.

Nisbet died in 1693 whilst his regiment was stationed in Glasgow, Janet was duly confirmed executrix creditrix, before the Commissary of Glasgow, whilst Monro was named executor creditor by the Commissaries of Edinburgh. Thus, a debate arose as to which city should process John Nisbet's testament. Monro argued, against to protestations of Janet Nisbet, that her brother could not have been considered a resident of Glasgow as he had only been stationed there for fewer forty days and had no fixed domicile. The Court of Session ultimately found in Monro's favour.

Smith was ably defended by John Inglis who contended that L'Angelier had either destroyed himself deliberately (citing his suicidal tendencies) or accidentally, as he was a hypochondriac with a tendency to incautious self-medication. Ultimately the circumstantial evidence proved tenuous, and the jury returned a majority verdict of not guilty. In later life Smith married George Young Wardle (1836-1910), foreman-manager of William Morris. She is the subject of Emma Robinson's novel Madeleine Graham (1864).

In 1834, following the recent passing of the Veto Act, the parishioners of Auchterarder unanimously voted to reject their patron's nomination of a new minister, Robert Young, and the Presbytery duly refused to proceed with his ordination and induction. Young appealed to the Court of Session which, in 1838, concluded that in passing the Veto Act the Church had acted ultra vires, and infringed the statutory rights of patrons. A supplement was issued in 1839.







The majority of the plate is registered by the chest in which it was housed, one marked as the property of Royal Navy officer Admiral Sir John Orde (1751-1824), another as belonging to the second baronet, Sir John Powlett Orde (1803-1878), who following the death of both his wife and father-in-law inherited Kilmory. Orde rebuilt the house in a Gothic style to a design by architect Joseph Gordon Davis, and remodelled the grounds with the aid of William Jackson Hooker. He was succeeded by his son Sir John William Powlett Orde (1827-1897) who, in 1880, obtained Royal Licence to assume the surname of Campbell-Orde. Kilmory is now the headquarters of Argyll and Bute Council.






